



Dear Treasurer,

I have pleasure in submitting the Annual Report of the Tasmanian Community Fund (TCF) for the year ending 30 June 2004, providing a snapshot of our program of grants to support a wide range of worthwhile community projects. This report is submitted in accordance with section 41 of the *Trust Bank Sale Act* 1999.

Since its establishment, the TFC has approved more than \$15 million in grants and assisted more than 400 projects in all regions of Tasmania. Undoubtedly, these projects and the support the Fund has provided, have made a significant difference to the lives and wellbeing of Tasmanians. Projects have ranged from medical research and assistance to health care, disabled and aged people's groups, to park and public land rehabilitation, arts programs and support for other community groups.

The full list of grant recipients and the projects and organisations supported, is available on the TCF website, www.tascommfund.org

In 2003-2004 a total of \$4.74 million in grants was approved in 127 different projects enabling community organisations around Tasmania to undertake or continue their work and activities. A total of \$1.8 million was provided for 52 projects in Grant Round 7 and \$1.94 million went to 72 projects in Grant Round 8. A further \$1 million was provided for three projects as part of our Early Childhood Intervention and Prevention Strategies for At Risk Children targeted initiative.

More detailed information on the grants and the projects being supported are contained in this Annual Report.

The diversity and value of the projects and the important contribution of Tasmanian community organisations being supported, serve to underline that the TFC continues to live its vision of working with Tasmanians to make a difference.

The TFC is a vital part of our State's community support fabric and my Board colleagues and I look forward to seeing the benefits of our grants program continue to assist and support Tasmanians into the future.

About the Fund

Establishment

The Tasmanian Community Fund (TCF) was established under the *Trust Bank Sale Act 1999* to provide grants to community organisations for worthwhile community purposes and projects. Under the Act, the TCF receives an annual appropriation from the State Budget equal to one half of the savings in interest costs that flow from debt retired following the sale of the Trust Bank.

This amount is a reserved-by-law appropriation and is not subject to annual budget deliberation. In 2003-2004, the Fund received \$4,590,133 in appropriations and \$366,823 in interest.

Vision

Working with Tasmanians to make a difference.

Our Identification

The TCF logo symbolises its objective of helping Tasmanians to make their mark. A thumbprint covering Tasmania is indicative of the TCF's reach over the length and breadth of our island state and its vision of working with all Tasmanians in all walks of life, to make a difference in our community.

 - 127 projects assisted statewide.

The Board

The TCF is managed by a Board of six members who, collectively, have sole and absolute discretion to consider and make grants for worthwhile community purposes.

Gerald Loughran, Chairman

Gerald is a former Chairman of the Trust Bank and the Trust Bank Foundation and is currently Director of a number of companies including Aurora Energy and Haywards Crisp Bros. Winifred Curtis Scamander Reserve Trust - Boardwalk



Construction of the walkway created challenges for the volunteers in the very wet marshland.

Grant Round No 7 saw the TCF provide \$20,500 to the Winifred Curtis Scamander Reserve Trust for the construction of a boardwalk.

The 'Boundary Track' in the Reserve crosses over a creek with an extensive Melaleuca swamp on one side and a wetland swamp on the other, impeding and preventing access to Steels Beach. A walkway was required to facilitate access and prevent further damage to the environment.

Volunteers assisted a semi-retired professional construction engineer to build the walkway, saving in labour costs. As well, materials were purchased at discount prices from supportive retailers.

After some delays due to inclement weather, the construction commenced on 12 March 2004 and was completed on 16 April 2004

Surplus timber was used to construct a picnic table for visitors to the reserve and a small amount of unspent grant money was returned to the TCF for reallocation.

How the TCF Makes its Decisions

Mission

The TCF is committed to making grants to community organisations that make a difference by enhancing well being and improving social, environmental and economic outcomes for the Tasmanian community.

Who may apply?

The TCF will consider an application for funding from an incorporated not-for-profit organisation that is:

- Based in Tasmania.
- Proposing to undertake a project in Tasmania.

Unincorporated not-for-profit organisations may also apply for a grant provided an incorporated organisation is prepared to sponsor the organisation.

Who we want to hear from

Generally preference is given to organisations that:

- Pursue or undertake community projects or activities.
- Encourage community involvement.
- Demonstrate sound financial and project management practices.
- Have sound organisational structures.
- Look to provide long-term solutions to community problems rather than simply short-term relief.

Projects that qualify

The TCF looks for projects that are genuinely responsive to the community's needs and:

- Have a significant and demonstrable benefit to the Tasmanian community or a significant section of the community.
- Have a sustainable and positive impact on the community.
- Are innovative and proactive in their approach and delivery.
- Demonstrate an integrated and collaborative approach to service provision.
- Represent value for money.
- Build and strengthen a particular community's capacity.
- Encourage substantial volunteer and community involvement with the project.
- Are self-sufficient at the end of the funding period.

Our Guiding Principles

The principles that guide TCF's funding policies support grants that:

- Build cohesive and stronger communities.
- Encourage innovative solutions and new approaches to issues.
- Maximise the value of grants and avoid duplication.
- Meet a demonstrable need.
- Promote sustainable and long-term outcomes.
- Promote community involvement and commitment.
- Encourage community organisations to work together

and form partnerships in the delivery of services.

The TCF will NOT provide funding:

- To a Commonwealth or State Government agency or a Commonwealth or State Government Business Enterprise or a local government body to fund its core responsibilities.
- To a political party.
- To an organisation whose primary purpose is the provision of grants or financial assistance.
- To an individual for:
 - ~ academic studies
 - ~ overseas travel for any purpose
 - ~ raising funds on behalf of charitable or similar organisations
- For projects which produce a private benefit to a specific business or person.
- Retrospectively.
- To conference organisers or potential attendees at conferences or symposia.
- In the form of a loan.

The TCF will NOT GENERALLY provide funding:

- To sporting clubs for the upgrade or maintenance of facilities or equipment.
- For the ongoing funding of project officers or support staff.
- To enable a study or inquiry to be undertaken, unless funding has already been secured to implement any outcomes arising from the study or inquiry.
- For ongoing administrative costs.
- For replicating a project that is already being delivered in the community.
- To pay off debt.

Project Areas

One of the TCF's greatest strengths is that it focuses its funding into 10 core areas that cover most community sectors across the state. The project areas funded are:

- Community welfare.
- Cultural and arts purposes.
- Economic development and employment.
- Education.
- Environment.
- Health.
- Regional development.
- Religious purposes.
- Sporting or recreational activities.
- Youth issues.

Grant Programs

The Tasmanian Community Fund has two grant programs:

- The Targeted Initiatives Program
- The General Grants Program

Targeted Initiatives Program

The TCF's funding programs have evolved over time and the launch of the Targeted Initiatives Program has broadened the scope of its community support and assistance. This targeted approach maximises the impact of funding by channelling support into a small number of major initiatives that have the capacity to achieve significant and sustainable benefits for the Tasmanian community.

The first two targeted initiatives identified for the program are:

- Early Childhood Intervention and Prevention Strategies for At Risk Children; and
- Promotion and Conservation of Tasmanian Heritage.

It is anticipated that the Tasmanian Heritage Targeted Initiative will be launched in 2004-05.

General Grant Program

The broad focus of the General Grants Program enables community organisations to apply for funding for projects that contribute to the quality of life in Tasmania, as well as assist those in need. In responding to funding requests, the Board assesses the projects based on their individual merits against the other competing priorities applying at the time.

The Board also monitors the distribution of funding on a statewide and regional basis, and across the different project areas.

Grant Round No 7

The TCF advertised details of Grant Round No 7 in the three major daily newspapers on 19 July 2003. In response, 201 organisations across all areas of the state applied for funding, requesting a total of \$12 million for their projects.

Following a rigorous assessment process, the TCF approved funding for 52 projects to the value of \$1.8 million.

Grant Round No 8

The TCF advertised details of Grant Round No 8 in local papers on 14 February 2004. The TCF received 232 applications in this grant round, requesting a total of \$14 million in funding.

The TCF approved grants worth \$1.94 million for 72 diverse community projects across the state. However, due to the timing of this grant round, the majority of the grants were not paid to recipients until the 2004-05 financial year.

Grants were announced at a number of planned media events and on the TCF website.

Making a Difference

The TCF's clear vision is to work with Tasmanians to make a difference. Some of the projects in 2003-04 that have made a difference to the lives of Tasmanians are highlighted throughout this Annual Report.

ADARDS Nursing Home - Residents' Bus Upgrade



The new bus plays an important part in the activities' program for residents.

In Grant Round No 7, the TCF approved funding of \$22,932 to assist with the purchase of an upgraded residents' bus for the

ADARDS Nursing Home. The Home's old bus was sold to contribute to the cost of the replacement vehicle which is being used for excursions such as visits to parks and gardens, other nursing homes, and public events.

ADARDS Nursing Home is a 36-bed facility for the accommodation of ambulant people with dementia. ADARDS is a non-profit organisation not affiliated with any similar service provider and the nursing home accepts residents who cannot be managed at home or in a general nursing home. The facility opened for its first residents in July 1991 and can be configured either as four self-contained houses or as four wings of a single ward around a central nursing station.

The upgraded bus was purchased in April 2004 and has fitted seatbelts, air-conditioning (which assists in behaviour management) and a specially designed step. The flexibility of the new vehicle has added significantly to residents' activities program.

The First Targeted Initiative

Early Childhood Intervention and Prevention Strategies for At Risk Children

There is an accumulation of evidence that successful intervention in early childhood offers the greatest potential for making a difference. The earliest years in life are the most important for child development, and very early development is influenced greatly by social wellbeing and environmental factors.

In many ways, children's early experiences set the stage for their later development. A difficult beginning can pose multiple risks for children's wellbeing and health. It can have a lasting impact on their chances for reaching their full life's potential. Supporting these children in the early years can yield lasting benefits – for the children themselves, for their families and for society as a whole.

Parents, guardians, extended family members and the community play a central role in nurturing children. Raising a child is an enormous responsibility, and parents need all the support they can get.

This initiative of the TCF is designed to improve the physical, emotional and social well being of young children under the age of three, particularly those who are vulnerable, by supporting projects that:

- Empower parents in caring for their children and build supportive networks around the family.
- Foster flexible and responsive services for families and children at the local level.
- Improve the capacity and competency of parents.
- Foster effective links and co-ordination among services for families within the communities.
- Build the capacity of communities to strengthen and support families with young children.

The TCF adopted a simplified two-tiered approach to selection of grant recipients. Applicants first submitted a concise two to three page expression of interest. Organisations with projects selected for further consideration were then invited to submit a full application.

A Funding Advisory Committee was established to assist the TCF in the assessment process. The committee consisted of TCF Board member Joan Walters, a registered nurse with experience in child health; Dr Sue Jenkins, a paediatrician who has worked internationally in the field of community child health; and Professor Robert Bland from the School of Sociology and Social Work at the University of Tasmania.

The TCF is greatly appreciative of the work of committee members in assessing the submissions.

A total of 44 expressions of interest was received and seven organisations were invited to submit full applications. The three projects selected for funding were announced in October 2003.

They were:

Good Beginnings Australia – \$386,199 over three years

This project provide for the establishment of a Professional Early Intervention Resource Services (PEIRS) program designed for families with complex needs who have children under three years of age. The program will be conducted in the southern region of the state and involves the employment of a male and female professional early intervention workers who will:

- Provide outreach services for both fathers and mothers.
- Provide professional support and resources to volunteer community parents.
- Implement the Life Skills Parenting program.

Northern Midlands Council – \$98,921 over two years

This project establishes the Campbell Town Be OK (Best Outcomes for Kids) Project. The Be OK project will work with the parents of children up to three years old and children at risk, to identify and help achieve their personal goals, including parenting goals. The project will work with the community and other relevant stakeholders to develop support services and systems that are readily accessible to parents of young children at risk. A part-time community worker will facilitate the project.

Northern Suburbs Community Centre – \$469,316 over three years

This project will establish the NEWPIN (New Parent Infant Network) program in northern Tasmania. NEWPIN is a self-help, early intervention family support program. The program offers an integrated package of care and support to families under stress comprising:

- Drop-in centre.
- Home visiting service.
- Befrienders and peer support program.
- Well equipped play room.
- Weekly therapeutic support group.
- Personal development program.
- School holiday programs.
- Fathers' program.

The drop-in centre will operate three days a week, employing four staff including a co-ordinator, play facilitator, play worker and an administration officer.

A summary of projects approved in Grant Round No's 7 and 8 is provided on the next page.

Successful Recipients

Grant Round No 7

ADARDS Nursing Home Inc - \$22,932

The purchase of an upgraded transport bus, with full seat belts, air conditioning and an extra step.

ARAFMI (Relatives & Friends of People with a Mental Illness) – \$29,828

The establishment of a Tas Kidz club to provide support and education to primary aged children who have a parent with a mental illness. The program will aim to promote resilience and prevent negative developmental outcomes in this population.

Bruny Health Library - \$2,500

The refurbishment of the existing library, including the replacement of old shelving, addition of new shelving, the purchase of new books and resource materials, and the purchase of materials for the maintenance of books.

City Park Radio Museum - \$9,740

Extensions to the existing building in City Park, Launceston, to accommodate the audio collection and offer more room for visitors and staff.

Cressy Cultural Committee – \$23,087

The creation of a cultural centrepiece/tourist attraction for the town of Cressy, using a new toilet block as the basis for the structure/display.

Early Learning Tasmania, Launceston – \$31.537

The re-development of the existing playground and equipment at the Early Learning Centre - Launceston. The aim is to make the playground more level, more accessible and more functional through the installation of new walls, paths, grass, playground equipment, and a storage shed.

Epilepsy Association of Tasmania Inc – \$47,280

The purchase of a Digital EEG machine to be used at the North West Regional Hospital, Burnie.

Family Planning Tasmania Inc - \$37,234

The establishment of ante-natal classes in both Burnie and Devonport to specifically target pregnant teenagers.

Family Planning Tasmania Inc (Welfare Association) – \$32,145

The upgrade and improvement of the existing building in Pine Avenue, Burnie to ensure equity of access for all people.

Fingal Valley Community Sporting Complex Inc (FVCSC) – \$90,000

The completion of Stage 2 and Stage 3 of the re-development of the FVCSC consisting of additional change rooms, a kitchen/kiosk facility and the demolition of the existing club rooms and the construction of a community recreation building at the FVCSC.

Friends of Claytons - \$4,180

The restoration and preservation of Clayton's Cottage, Melaleuca Inlet (Port Davey), through subsidised travel expenses. The cottage is used as a shelter for those bushwalking and journeying into the area.

Friends of Kate Reed Nature Reserve – \$17,198

The construction of an 180-metre boardwalk across wetlands and the Kings Meadows Rivulet to connect to an existing walking track within the Kate Reed Nature Recreation Area.

The Vine Christian Church Care Service - Repairs to the old Ravenswood High School

The TCF provided \$90,000 to the Vine Christian Church Care Service in Grant Round No 6 to enable it to upgrade a section of the old Ravenswood High School and establish a community 'round house' as an ongoing forum for community youth needs

and development.

Prior to this work, the school building was subject to significant vandalism and neglect, rendering it virtually unusable. Extensive repairs were carried out to the windows, toilets and roof, rooms were repainted, floors carpeted and the kitchen refurbished. A range of sport and recreational equipment was purchased, including table tennis and exercise equipment, a data projector, computers and heaters.

The building is now established as a thriving youth centre for a range of activities, including:

- A weekly Kids' Club for children aged between five and 13 years. Up to 70 local children attend at any session.
- Creative arts training week, organised by Youth with a Mission.
- A fitness room, for use by youth under supervision.
 The room is also available two mornings per week for members of the community at a nominal fee.
- A community round-table.
- Wedding receptions for a nominal fee.

Furneaux Historical Research Association – \$5,600

Conservation and display of the Furneaux Historical Research Association—Tasmanian Aboriginal Shell Necklace Collection. This is to be achieved through the purchase of six perspex wall display cases and a custom-built storage cabinet with display lids.

Giant Steps Tasmania – \$14,760

The creation of a properly-equipped, dedicated resource facility at the Giant Steps Centre, as well as the purchase of additional library resources to support learning and development, including appropriate computer software. Giant Steps is an organisation that works with children with Autism.

Good Beginnings Australia – \$96,578

The establishment of the Tottenham Early Years Family Support Centre (Gagebrook), initially through the part-time employment of a Community Connector (facilitator), who will assist local services to work in a more integrated way to enhance health and well-being outcomes for children and families. They will also facilitate the design of a local model that promotes sharing resources, building relationships and promoting Gagebrook as a happy and healthy community.

Headway Support Services – \$93,044

The purchase of a 21-seater Coaster Bus and conversion to allow wheelchairs to be transported safely.

Huon Valley Concert Band - \$4,000

The purchase of a set of two Timpani (kettle drums) for use by the percussion section of the Huon Valley Concert Band.

Interweave Arts Association – \$11,266

To provide computers and internet access to the five Arts Roar

committee members, along with technical advice/support, to improve the services available to marginalised members of the Launceston community.

is theatre ltd - \$21,000

The EAT 2 Community Outreach Program which aims to deliver seven quality community arts projects across regional Tasmania each year for two years, using the fund to cover travel and accommodation costs.

Kentish Youth Services - \$10 000

The completion of Stage 2 of the Sheffield Skate Park and entertainment area.

Kingborough Community Enterprise Centre – \$6,490

The purchase of a data projector and lap top computer to enhance the quality of visual presentations and facilitate the learning experience at the Kingborough Community Enterprise Centre.

Launceston PCYC - \$85,800

Grant approved but revised project is being considered by the TCF.

Lions Club of Kingborough - \$11,500

To construct a barbecue facility at Dru Point for disabled persons.

Lions Club of North East Tasmania – \$9.700

The improvement of the Branxholm River Access Walk, through the erection of interpretive signs (as per Nature and Eco tourism Accreditation Program), installation of rest seats and an upgrade of the track from W2 to W1 (Tasmanian Walking Track Strategy) to allow for wheel chair access.

Huon Valley Concert Band – purchase of Timpani

The TCF approved \$4,000 towards the purchase a set of timpani (two kettle drums) for the Huon Valley Concert Band as part of Grant Round No 7.

The Huon Valley Concert Band is a community music group dedicated to providing opportunities for local amateur musicians to meet and play together. The band plays at a wide range of local events including festivals (A Taste of the Huon, Huon Show) and other special events such as Australia Day Awards and Anzac Day. It also regularly presents more formal concerts, often in conjunction with other groups such as school bands and local choirs.

The band of some 30 musicians, comprises brass, woodwind, and percussion instruments and performs at between 12 and 15 events each year

Band members usually provide their own instruments, however, the larger instruments have been funded by the band as a whole. In the past the timpani has been borrowed from other bands, when available, or the musicians have performed without the timpani set.

The kettle drums were purchased in June 2004 for \$7,295. The Band funded the balance of the cost from member contributions, concert proceeds, and donations.

Already, the timpani have been used at a concert at the Federation Concert Hall in Hobart and a workshop at Huonville High School.

Band Music Director Joe Cook said: "With the addition of the timpani to our lineup, the band repertoire can be considerably widened, enabling us to present a much more professional sound."

Mainstage Theatre Company - \$15,000

The adaptation of the novel For the Term of His Natural Life into a fully staged, orchestrated production.

May Shaw Health Centre - \$160,000

The purchase and preparation of Lot 39 Wellington Street, Swansea, to establish a health and wellbeing centre, including rooms for meetings, forums, equipment lending library, youth services, carer services, and allied health professionals.

Menzies Research Institute – \$93,656

The examination of the role of biological and lifestyle factors in childhood in determining early atherosclerotic changes in young adults.

Mole Creek Progress Association Inc – \$35,000

The establishment of a rural transaction centre in Pioneer Drive, Mole Creek, which is to contain the following facilities: Parks and Wildlife Information Centre, District Headquarters, Sales Office, Cave Bookings and Parks and Wildlife Manager; Mole Creek Visitor Information Centre; Online Access Centre; photocopying services, Mole Creek Committee/professional meeting room; local crafts display; and Medicare Easy Claim booth.

Montagu Community Living Inc - \$35,437

The purchase of a small van fitted out for wheelchair accessibility, for the purpose of transporting the residents of Montagu Community Living Inc, primarily those within the Personal Support Program.

MST Workplace Solutions - \$40,000

The upgrading of the Dooley Heritage Trail (18.5km) at the Wilmot River Recreation Area (near Devonport), including surveying for suitable picnic/toilet sites and their subsequent construction.

Mt Lyell ABT Railway Society Inc – \$30,000

The removal of asbestos lagging from the Abt No 3 & 1 boilers and the display of its workings designed for the public. The erection of a small shed structure to house the display boiler. The project will also include the restoration of two, old wagons for display and a general clean up and beautification of the site.

Development of the Mt Direction Relay Site as part of the historic Tamar Valley Semaphore System. This project will include: siting and erection of a footbridge as part of the walking track, archaeological survey, site protection and interpretation, and a public awareness program.

Scope

The financial report and the Trustees' responsibilities

The financial report comprises the Statement of Financial Performance, Statement of Financial Position, Statement of Cash Flows, accompanying notes to the financial statements, and the Certification of Financial Statements for the Tasmanian Community Fund for the year ended 30 June 2004.

The Trustees are responsible for the preparation and true and fair presentation of the financial report. This includes responsibility for the maintenance of adequate accounting records and internal controls that are designed to prevent and detect fraud and error, and for the accounting policies and accounting estimates inherent in the financial report.

Audit approach

I conducted an independent audit in order to express an opinion to the members of the Parliament of Tasmania. My audit was conducted in accordance with Australian Auditing Standards in order to provide reasonable assurance as to whether the financial report is free of material misstatement. The nature of an audit is influenced by factors such as the use of professional judgment, selective testing, the inherent limitations of internal control, and the availability of persuasive rather than conclusive evidence. Therefore, an audit cannot guarantee that all material misstatements have been detected.

I performed procedures to assess whether in all material respects the financial report presents fairly, in accordance with Accounting Standards and other mandatory financial reporting requirements in Australia, a view which is consistent with my understanding of the Fund's financial position, and of its performance as represented by the results of its operations and cash flows.

I formed my audit opinion on the basis of these procedures, which included:

 Examining, on a test basis, information to provide evidence supporting the amounts and disclosures in the financial report, and Assessing the appropriateness of the accounting policies and disclosures used and the reasonableness of significant accounting estimates made by the Trustees.

While I considered the effectiveness of management's internal controls over financial reporting when determining the nature and extent of my procedures, my audit was not designed to provide assurance on internal controls.

The Audit Opinion expressed in this report has been formed on the above basis.

Independence

In conducting my audit, I followed applicable independence requirements of Australian professional ethical pronouncements.

Audit Opinion

In my opinion the financial report of the Tasmanian Community Fund:

- a) Presents fairly the financial position of the Fund as at 30 June 2004, and the results of its operations and its cash flows for the year then ended; and
- Is in accordance with applicable Accounting Standards and other mandatory professional reporting requirements in Australia.

Notes to the Financial Statements for the year ended 30 June 2004

Note 1: Statement of Significant Accounting Policies

The Tasmanian Community Fund was established under section 33 of the Trust Bank Sale Act 1999. These Statements cover the period from 1 July 2003 to 30 June 2004.

(a) Basis of Accounting

Under the provisions of the Trust Bank Sale Act 1999 the Board is required to keep proper accounts and records of its transactions and affairs.

The financial statements have been prepared in accordance with Australian Accounting Standards, Urgent Issues Group Consensus Views and other authoritative pronouncements of the Australian Accounting Standards Board.

(b) Purpose

The Tasmanian Community Fund is used to fund the payment of grants for community purposes. These include grants for community welfare, sporting or recreational, cultural and arts, educational, religious purposes, youth issues, health, environment, regional development and economic development and employment.

(b) Revenue Recognition

Revenue is recognised when receivable.

(c) Taxation

The Tasmanian Community Fund is not subject to income taxation. However, the Board has fully complied with the requirements of the Goods and Services Tax.

(d) Cash and investments

Cash and short-term investments are carried at face value of the amounts deposited. The carrying amount of cash or investments approximate net fair value.

Note 2: Economic Dependency

In accordance with section 33 of the Trust Bank Sale Act 1999, the Tasmanian Community Fund receives an annual appropriation through the State Budget. This funding is provided from the Consolidated Fund and is a Reserved by Law appropriation, in accordance with the provisions of the Act.

Note 3: Audit Information

The Tasmanian Audit Office conducted the audit of the Tasmanian Community Fund. Audit fees of \$1,125 (excluding GST) were paid during 2003-04.

Note 4: Remuneration of Board Members

(a) The Tasmanian Community Fund Board was appointed on 26 July 2000.

In Grant Round No 8, the Tasmanian Community Fund approved a grant of \$47,500 to the Royal Guide Dogs Association of Tasmania to purchase mini and model dogs for fundraising collection.

The Royal Guide Dogs is a registered charity, providing specialist services throughout Tasmania to people who are blind or vision impaired. The services include training and support in the use of the long cane; mobility support; specialist occupational therapy support; adaptive software and hardware technology; the provision of equipment and training in adaptive daily living, as well as guide dog mobility services.

The Royal Guide Dogs operates a diverse range of fundraising streams. A mainstay of its effort is the highly recognisable mini and model dog program. Funds are raised through the positioning of mini dogs sitting on shop counters and the larger model dogs in prominent places in supermarkets and larger retails stores. The program raises more than \$30,000 each year to support the provision of ongoing services. Most of the mini and model dogs are more than 20 years old and need replacing. A new range of more realistic mini and model dogs has been developed to provide significantly greater public appeal.
