#### CHAIRWOMAN'S MESSAGE

It is a privilege to present this message on behalf of the Board of the Tasmanian Community Fund. This annual report is the Fund's way of reporting on its activities to the Tasmanian community, and is therefore a most important part of what we do. The Fund is responsible for distributing over \$5 million each year, money held by the State after the sale of the Trust Bank in 1999. These funds now make a difference to community groups across Tasmania.

#### **CHANGES IN THE BOARD**

Catherine Fernon served on the Board for 8 years, until members regretfully accepted her resignation in December 2011. Mark Fishwick was appointed by the Governor to take her place, and it is expected that in keeping with the representational traditions of the Board, he will give voice to the particular concerns of communities in the northwest and west of the State.

All board members participated in the activities of the Fund over the year: board meetings, attendance at community forums, and attendance at community events associated with successful grants. External assessment during the year confirmed that the Board is diligent and professional in its approach, working to ensure that grant monies are allocated as fairly and effectively as possible within the State. All Board members are honoured to be able to represent the Tasmanian Community Fund, and continually strive to make sure that the Fund keeps making a difference in communities.

#### **GRANT ROUNDS**

This year the Board changed its processes for the allocation of grants of more than \$100 000. The number of applications for grants of this size has increased significantly in recent years, while available funding has increased only by the increase in the Consumer Price Index. The Board recognised that applicants needed to devote considerable effort and resources to submitting an application, and sought to find ways to lessen this burden on community groups.

It was decided that only one round of funding would be considered for grants of more than \$100 000 each year. Applicants were invited to submit a brief summary of their proposed project, and from these expressions of interest, eight applicants were requested to provide a full application, including business plans and fully detailed budgets. The Board invited a number of these applicants to make a presentation to the full Board, a process which allowed us to meet the responsible parties and ask questions about the project.

Board members found that discussing the proposal with applicants led to greater understanding of the reasons for wanting to do the project, and more detailed knowledge of the proposed methodology. It also helped for all Board members to hear the same information from applicants.

#### SUBMITTING APPLICATIONS

This year the Board trialled electronic grant submissions, with some Board members assessing all applications on computer, while others continued to peruse the paper versions. As has been the practice since inception, all board members assess every application, and the decision on each application is made collegiately in the assessment meetings. Until this year this has meant large volumes of papers in heavy document boxes at all assessment meetings. The Board has decided that the sheer volume of applications merits the introduction of more streamlined processes, both for assessment by board members, and for maintenance of records by staff. In 2013 all applications will be provided to board members electronically, and laptops will replace stacks of document boxes in the board room.

#### **BOARD AND STAFF**

During the year Melissa Gunn, the Administrative Officer, took on a new role within the public service. Her dedication to the Fund and her broad knowledge of the applicants and the communities they serve was acknowledged with thanks by Board members, both past and present.

The Board thanks Lola Cowle, its Senior Executive Officer, for her sterling work throughout the year, and in particular for her support during times of challenge and change.

#### LOOKING TO 2013

In tough economic times communities reach out to the Fund for assistance for projects no longer funded or likely to be funded by other providers. The Board recognises that the trend towards a greater number of applicants requesting larger sums of money is likely to continue.

On the one hand, this means that the Fund must continually strive to meet community needs within the limited resources available to it, and simultaneously streamline its processes to provide the greatest amount of assistance possible to applicants. On the other hand, more applicants asking for grants is reassuring for the Board, indicating as it does a greater number of Tasmanians who are aware of the Fund and are prepared to apply for a grant.

Most reassuring of all, more applicants requesting grants confirms yet again that the strength of the Tasmanian community lies in its ability to devise successful communal solutions to community problems. The Tasmanian Community Fund will continue to help those resilient resourceful communities make a difference to our State.

The first step in the process was the acceptance of emailed applications from Round 24 and the final step will be the implementation of a SmartyGrants electronic lodgement system from Round 26, in early 2013. These processes will not only be more streamlined for Board members and staff but should make project application lodgement and project reporting easier for community groups as well.

I would like to thank the Board for their support and encouragement over the last 12 months. I am constantly astounded at their vast pool of knowledge of the Tasmanian community and the projects that are occurring across the state. I would particularly like to thank them for their willingness to share their knowledge and wisdom. Their professionalism and commitment to the Fund and ensuring the best outcomes are achieved for the Tasmanian community are also to be applauded.

I would like to thank Melissa Gunn and Gill Mosmann for their work with the Fund. After many years as the Administrative Officer with the Fund Melissa has moved on to a new role. Melissa worked tirelessly during her time with the Fund to improve and upgrade the systems and processes of the Fund and to help the community achieve their desired project outcomes.

Gill temporarily filled the role of Administrative Assistant with the Fund during the year. During her brief time with the Fund, Gill filled the role admirably and provided great support to the Board and to the community. I wish them both well with their future endeavours.

Finally, I would like to congratulate the Tasmanian community organisations for their dedication and hard work in making Tasmania a better place and for their commitment to ensuring that their Tasmanian Community Fund projects are successfully implemented.

I look forward to working with the Board and Tasmania's community groups to further develop the Tasmanian Community Fund for the benefit of all Tasmanians.

# ROSS FEMALE

## **ROSS FEMALE FACTORY**

The Tasmanian Wool Centre in conjunction with the Tasmanian Parks and Wildlife Service received Tasmanian Community Fund support to implement two projects at the Ross Female Factory.

In the first project, an interpretation plan for the site was devised, and after a number of surveys and successful planning applications, a stone filled gabion wall was built round the perimeter of the site, and interpretation panels erected. In the second project, lighting, interpretation panels and display cases were installed in the overseer's cottage and restoration works were completed across the site.

The upgraded interpretation has made it possible to tell the stories of the women and their gaolers and brought colour and 'life' through their stories to visitors. With the nearby convict built Ross Bridge, the site is now one of our most important reminders of Tasmania's convict heritage. Through the project the local community has developed a greater awareness of the significance and value of the site and particularly its place in Tasmania's convict story. This knowledge has provided the people of Ross with a sense of ownership and pride in the site and has led to far greater sharing of their knowledge with others outside the community.

In time it is hoped that the improvements to the site and the increased knowledge and pride in the site by locals and Tasmanians alike will lead to a greater number of visitors to the area. This will play a part in maintaining the small but vibrant community of Ross.



## TASMANIAN SYMPHONY ORCHESTRA

The Tasmanian Symphony Orchestra (TSO) received funding support from the Tasmanian Community Fund for choir risers. The TSO Chorus performs regularly with the TSO at the Concert Hall in Hobart.

After singing for many years on scaffolding and various other odd platforms the risers are a wonderful asset for the TSO. The risers enable the Chorus to stand comfortably and see the conductor clearly and there is greater visual integration between the orchestra and Chorus when the audience sees the entire ensemble. It gives a sense of unity, harmony and working together and provides for a better overall experience for the audience and performers.

One essential for good singing is to have sufficient space for each chorister to be able to stand without being cramped against neighbours – something the new risers provide. This has enhanced the quality of the sound of the Chorus.

One Chorus member commented that as a centrally located Chorus member she had become used to hearing nothing but the people next to and immediately behind her, but now the risers enable her to hear the entire Chorus. 'It's wonderful to be able to hear the outside ends of the choir!' Another Chorus member stated that he loves the fact that the risers match the stage timber and the orchestra risers, and almost seem to grow out of the stage floor. He also commented that they provide a solid 'sounding board' under the Chorus' feet, a bit like a piano, enriching the acoustics of the choral sound.

The choir risers have also made a difference for audience members, with one person commenting that the individual Chorus members can now be seen, rather than being hidden behind each other. This gives the audience a sense of the 'whole' Chorus and also improves the sound quality; one can more easily follow the interplay between different sections, their counterpoint and their relationship with the conductor and soloists.

A further Chorus member commented that the risers are a definite boon to performances.

## **GRANT ROUNDS**

Since its inception the TCF has held two general grant rounds each year, in February–March and July–August.

From time to time, we also hold targeted funding rounds. These rounds maximise the impact of funding by channelling investment into fewer, larger initiatives that have the capacity to achieve even greater benefits to the community.

The four targeted rounds conducted so far have been:

- Early Childhood Intervention and Prevention for At-Risk Children – \$1 million for three projects;
- Promotion and Conservation of Tasmania's Cultural Heritage – \$2 million for 31 projects;
- Tasmanian Aboriginal Heritage \$280 000 for 7 projects; and
- Building Tasmania as the Learning Community with a focus on adult and family literacy
  - \$2.8 million for nine projects in round one;
  - \$1.3 million for eight projects in round two; and
  - \$578 000 for seven projects in round three.

The Smith Family received funding from the Tasmanian Community Fund to run a series of Family Learning Clubs in four areas around Tasmania. The Learning Clubs operate in primary schools and are run over six week blocks each term and are offered to participants through referrals from the school.

The aim of the Family Learning Club is to support the educational and personal development of students in a safe and supportive environment, where they can access resources, develop new skills and strengthen relationships between themselves and their parent or significant others in their lives. Family Learning Clubs provide an opportunity for children to further develop their skills and confidence, to build on their school based learning, and for parents to contribute more fully to their children's learning whilst building strong and more sustainable family relationships.

The theme for the most recent Family Learning Club, run in partnership with Colony 47 at Windermere Primary, was making puppets out of junk and was offered to children in grades three and four.

At the start of the program Stacey revealed that she was struggling with her son Jarad's behaviour and was finding it difficult to connect with him. She seemed quite anxious in her role as a single parent. Their goal was 'to become better friends and enjoy time together'. During the six week program Stacey was able to relax more in the company of Jarad and others. They had fun making a puppet together and Stacey commented on how being involved in the program allowed her the opportunity to spend some quality time with Jarad without the distractions from his younger sister, which has strengthened their bond and helped them appreciate each other's strengths.

Stacey also talked about the Family Learning Club providing a welcoming, comfortable environment with staff providing assistance with parenting issues as required. She said she felt comfortable that help was at hand to deal with Jarad's challenging behaviour and didn't feel judged. Stacey said she learned new strategies in dealing with inappropriate behaviours, felt much more confident in her parenting role and now acknowledged many people struggled as she had. Stacey has offered to be a Smith Family volunteer in upcoming Family Learning Clubs that Jarad will not be attending. She has even accepted some teacher aid work in the school.

Jarad also seemed more relaxed as the weeks went by, his interactions with his mum much more natural, with mum even receiving hugs along the way which in the past were unusual. He became a responsible group member and received a 'safety guru' badge one week for his particularly safe work with tools and people around him. Jarad invited his father along to his celebration session. Jarad's dad drove for 2 ½ hours to attend and the excitement from Jarad was obvious.



## SORELL GIRL GUIDES

Sorell Girl Guides is one of the fastest growing Girl Guide Units in Tasmania. In the last two years the Unit has grown from just over 20 girls to close to 70. This rapid growth coupled with limited and ageing equipment was placing some limitations on the program that Leaders could offer to the Girl Guides.

Through the Tasmanian Community Fund the Sorell Girl Guides were able to purchase new camping and outdoor equipment. The outdoors has always been a focus and Leaders are now able to offer these experiences to all Sorell Girl Guides (5 to 13 year olds). Not only do the Girl Guides have the opportunity to experience camping but they learn to cook on more modern gas cookers, and develop teamwork skills as they negotiate a diverse range of activities. They are able to participate in many local, regional and State events that further develop their skills. The equipment has decreased the burden on Leaders who were having to source additional equipment from friends and family. The Leaders are now able to concentrate on the program and activities that they are delivering to the Girl Guides, thus improving their learning and experience outcomes.

Using the new equipment the Girl Guides have created many wonderful memories whilst also improving their teamwork, communication and leadership skills. They have been able to participate in events and camps that have improved their water craft and bushcraft skills, helped them understand the environment and world they live in and helped them form and establish new friendships, networks and build their understanding of individuals and how they work together.

J was referred to the Save the Children Australia's Supporting Young People on Bail program in May 2012 by the Early Intervention Unit, Tasmania Police. J is 17 years old and has been disengaged from school since the middle of Grade 9. J has had a history of offending. This year his offending reached a point where he was at risk of being placed in Ashley Youth Detention Centre.

Glen McNeill, Save the Children Australia's Youth Worker, met with J to find out what his educational/vocational and recreational goals and aspirations were. J identified that he was interested in mechanics and wanted to work in the gym with weights.

Glen helped J put in an application for Mission Australia's UTurn program and he was able to start on his Certificate 1 in Automotive in July. J has been making very positive progress in the course which includes both automotive skill development and literacy and numeracy. The Save the Children Australia Youth Worker has been supporting J to attend UTurn by providing transport to and from the program on a regular basis.

To date, J has completed the Welding and Spray Painting Units and is now engaged in the Auto component of the course.

J readily admits that when he completes the course he will be the only member of his family that has graduated with a nationally recognised training certificate. He would like his father to attend the graduation ceremony.

Glen introduced J to the Hobart PCYC and he has been attending regularly and has participated in indoor soccer, basketball and weights. Glen and J have lunch together before these activities.

J has successfully attained his Learner's Licence and now trains as a boxer in the evenings. He hopes to enrol in Certificate II Automotive at the Trade Training Centre as the next step in his education.

J received a suspended detention order from the Youth Justice Court Magistrate.

J says that participating in the Supporting Young People on Bail program has been a 'happy' experience for him and the support he has received has made a 'big difference'. He said that he is doing things that he is interested in. 'Boxing is something I have always wanted to do.' J says that 'being involved in the program has changed my life.'

## RURAL HEALTH TASMANIA INC

Rural Health Tasmania Inc manages the CLOCK project, an Adult Literacy program called 'Learning While Having Fun'. This joint project run by Rural Health Tasmania Inc and the Circular Head Education and Training Consultative Committee acknowledges that broad changes to literacy levels across a community cannot be achieved by a single person or project and that there is sound evidence that adults learn most easily when they are exposed to a stimulating and supportive environment. Therefore the aim of the Learning While Having Fun project is to deliver a diverse range of fun and interactive literacy based activities.

From the start of 2010 there have been over 150 activity sessions held that cover a wide range of topics including first aid, cooking, budgeting, gardening, personal development, basic computing, creative writing, basic sewing, creative arts, needle felting, family history, CORES and save-a-mate.

Sam has been involved with the Women's Cooking program which is being held fortnightly in Circular Head. She has been hands on in each cooking session, making soups, main courses and desserts. Under protest she has tried new recipes and strange ingredients like cumin, coriander, nutmeg, garlic, ginger, feta and parmesan cheese, fresh thyme and chives, chillies (dried and fresh), pesto, soy, oyster and hoisin sauce and curry powder. Along with these ingredients came an assortment of fresh vegetables that she did not usually buy: everything from sweet potato and zucchini to bok choy and chinese cabbage.

When asked what she thought of the cooking sessions she said, 'They're good and I enjoy cooking new things. Learning new things to cook has been fun and I want to keep learning how to cook healthier meals for my family.' The initial comments of 'We're not putting that in,' or 'We'll leave that bit out,' have now changed to 'I like that recipe, it was really nice,' and 'Where can I get that?'

The recipes provided are kept in a folder and she has used some of them at home. Making pizza bases was a new skill and she has made scones at home too. She has also shared recipes with others. Sam requested copies of extra recipes that she saw while browsing through the Chinese cookbook. Sam is expecting her second baby in October and when she worked out dates ahead she was very pleased to see that she won't miss any cooking sessions when the baby arrives.

#### BACKGROUND TO THE TASMANIAN COMMUNITY FUND

#### Trust Bank sale

The Tasmanian Community Fund was established in 1999 to provide grants to not-for-profit organisations.

The Fund arose from the sale of the Trust Bank. As part of that sale, a community fund was created. In recognition that there was no owner at law, the sale proceeds were used to gain two particular benefits to the community:

- retirement of a portion of State debt; and
- an annual appropriation for the Fund's Board to allocate to the community through grants.

The legislation provided that the appropriation would be maintained in line with movements in the consumer price index.

#### Tasmanian Community Fund Act 2005

In 2005, Parliament passed stand-alone legislation which governs the Fund's operations. The new legislation preserved the main principles enshrined in the original legislation including:

- the Board has full autonomy to set the Fund's direction and award grants; and
- funds provided to the Board for distribution are guaranteed under legislation and not subject to Budget deliberation.

Under the legislation, Board members must act honestly and in the best interests of the Tasmanian community and avoid any conflict of interests.

#### Vision

Our vision is to work with Tasmanians to make a difference.

#### Mission

We provide grants to community organisations that *make a difference* by improving the social, environmental and economic wellbeing of the Tasmanian community.

#### **FUNDING ALLOCATED**

Since 2000, the Board has assessed almost 6 000 applications for funding, requesting over \$270 million.

Following a rigorous assessment of each of those applications received in 24 general rounds and four targeted funding rounds, the Board has approved \$61 million in grants to 1 800 projects.

The amount of funds allocated, and the number and variety of projects funded, makes the Fund a significant source of funding for Tasmanian community organisations. In 2011–12, total funding of \$6 million was awarded to 222 projects.

#### TASMANIAN COMMUNITY FUND BOARD

#### **Board Functions:**

Under the Act, the Board's functions are to:

- provide grants out of the Fund for community purposes as the Board thinks fit;
- manage the Fund, in any manner in which the Board thinks fit, so as to maximise the return earned on the Fund, having regard to the need to:
  - provide grants; and
  - exercise reasonable care and prudence so as to maintain the integrity of the Fund; and
- conduct its operations in an efficient, effective and economical manner.

At its discretion, the Board may:

- distribute the whole or any part of the Fund's balance; or
- accumulate the whole or any part of the balance and to invest that amount to distribute in future financial years.

In performing its functions and exercising its powers, Board members must:

- act honestly in all matters;
- declare any conflict of interest, and not participate in decisions relating to such a conflict of interest; and
- ensure that their functions and powers are performed in the best interests of the Tasmanian community.

The Board has developed a code of conduct governing the operation of its members to ensure that its activities are conducted according to the highest standards. The code of conduct is available on the TCF website at www. tascomfund.org or by contacting the Fund's office.

#### **Conflict of Interest**

Board members must declare any potential conflict of interest and not participate in any decisions relating to those conflicts. Board members complete a 'declaration of interests' form at the start of each year and update the declaration if circumstances change during the year. New members complete the declaration at the commencement of their appointment.

The Act provides for the imposition of significant penalties if Board members fail to declare those interests.

#### Gifts

To help ensure all decisions are made, and seen to be made, fairly and impartially, Board members are unable to accept gifts from potential applicants or grant recipients.



## NATIONAL STROKE FOUNDATION

The Tasmanian Community Fund provided support to the National Stroke Foundation to deliver the Know Your Numbers program.

High blood pressure is the single biggest modifiable risk factor for stroke but many Tasmanians are unaware of their blood pressure numbers. The Know Your Numbers program promotes the importance of regular health checks and awareness of modifiable risk factors to help prevent stroke, the second biggest killer of Australians.

The National Stroke Foundation teamed up with over 60% of Tasmanian pharmacies to offer free blood pressure testing. Testing was also undertaken at Agfest and at other events. By checking blood pressure pharmacists and health care workers were able to help identify people who may be at risk of stroke and cardiovascular disease and refer them to their doctor for advice on how to lower their risk and stay healthy. As part of the testing participants also answered questions about other risk factors and were provided with information on cardiovascular disease and stroke.

The National Stroke Foundation and its project partners will collate the data from the checks (both the blood pressure results and the questionnaires) and will use this to gain an insight into some of the underlying health issues that the Tasmanian community is facing. Once collated, the data will help the National Stroke Foundation and its project partners to plan future projects and community campaigns.

#### Lynn Mason – Chairwoman

Lynn retired as President of the Local Government Association of Tasmania in 2006 after 23 years as a Flinders Councillor. She is a director and deputy chairman of Metro Tasmania and is a life member of the Local Government Association of Tasmania. With her husband, she runs farms on Flinders Island and near Carrick in northern Tasmania. She was Telstra Tasmanian Businesswoman of the Year and Westpac Australian Business Owner of the Year in 2000, and in 2005 was inducted onto the Tasmanian Honour Roll of Women.

Lynn was appointed to the Board in March 2007 and was appointed as Chair in December 2009.



#### Ron Sanderson

Ron has extensive experience as an engineer and local government administrator. He is currently General Manager of the Brighton Council, with 24 years of local government experience within Tasmania giving him an extensive state-wide network of contacts. Ron also spent 14 years as an engineer in the oil and gas industry working in Canada, Western Australia and Victoria.

Ron was appointed to the Board in 2007 and reappointed in 2010.



#### Peter Kay

Peter has significant experience in corporate governance, management, public relations and corporate communications. He has held senior positions in Australian Government departments and statutory authorities providing funding and in the private sector in Tasmania, where he was Manager, Marketing and Public Affairs for the RACT, Chief Executive of communications firm Kay & Kay and a Director of the Printing Authority of Tasmania.

Peter was appointed to the Board in January 2010.



#### Nell Kuilenburg

Nell has over 25 years experience working in the non-government sector. She is Development and Research Manager with The Salvation Army Tasmania, and has worked with a number of non-government and Commonwealth Government agencies. She has been a board member of several non-government organisations and networks at both a state and national level covering family violence, child abuse, aged care, housing services and resettlement for CALD communities.

Nell was appointed to the Board in January 2010.



#### Sheryl Thomas

Sheryl has significant experience in assisting not for profit community organisations across Tasmania in accessing funding to grow communities, through a previously federally funded program. While Sheryl has always lived in Launceston, her past employment positions have allowed regular visits to all parts of Tasmania, allowing for a greater understanding of projects that can contribute to successful outcomes. Sheryl also has commitments to education and training.

Sheryl was appointed to the Board in January 2010.

#### Mark Fishwick

Mark has enjoyed over 25 years of membership of community service organisations and has developed a strong understanding of the benefits that philanthropic, volunteer and benevolent organisations provide to the Tasmanian community. With 11 years as a Company Director in the private health sector, with specific roles in finance, audit and managing risk, Mark has developed corporate governance skills that will also assist in his role with the Tasmanian Community Fund.

Mark was appointed to the Board in February 2012.

#### **BOARD MEMBER APPOINTMENTS**

The Board has a mix of financial and community-based experience. By convention, three members are based in the south, two in the north and one in the north-west. Under the Act, Board members are appointed by the Governor on the recommendation of the Minister with administrative responsibility for the Act. Before making a recommendation to the Governor, the Minister must first consult with the current Board.

Board members are appointed for a maximum of three years and may be re-appointed.

Catherine Fernon resigned from the Board in December 2011 due to a change in personal circumstances.

Mark Fishwick was appointed to the Board in February 2012.

#### REMUNERATION

Board members receive remuneration in recognition of their responsible position managing a significant pool of public funding. Board fees are set by Cabinet in line with parameters for similar entities.

Under the terms of their appointment, Board members are also entitled to receive reimbursement for any reasonable out-of-pocket expenses while performing their duties.

Member remuneration is provided from the Fund's reserved-by-law appropriation.

Further details of Board fees and on-costs are included in the financial statements to this report.

#### **BOARD MEETINGS**

Board meetings are held regularly throughout the year and in various locations around the State.

#### **FUND STAFF**

Fund staff are the main point of contact for the public. Staff manage the day-to-day operations of the Fund and support the Board in undertaking its activities. Their role includes:

- providing advice to potential grant applicants and grant recipients;
- presenting community forums and grant writing workshops;
- coordinating the grant application process;
- managing administrative arrangements for grant recipients;

- representing the Board at community events;
- liaising with other philanthropic organisations; and
- providing advice and research support to the Board.

Under the Act, Fund staff are State Service employees. The Department of Premier and Cabinet provide administrative services for the Board.

#### AS AT 30 JUNE 2012, TCF STAFF WERE:

#### Lola Cowle - Senior Executive Officer

Lola joined the Tasmanian Community Fund in May 2010. Before joining the Fund, Lola was the State Executive Officer for Girl Guides Tasmania and had previously held roles with other community organisations. Lola volunteers with a broad range of community organisations and has a passion for supporting her community.

Since joining the Fund Lola has gained a greater understanding of the number of community organisations working for the benefit of Tasmania. Lola looks forward to supporting these organisations to develop and deliver successful Tasmanian Community Fund projects.

#### **Community Forums**

Community forums are an opportunity for the TCF to inform the public about how to apply for funding, and the types of projects supported by the TCF. They are also an opportunity for the community to inform the Fund about local issues.

The Fund targets regions where applications may not be as strong, to help ensure all areas of the State have equitable access to the funds. This year, the Board held forums in Devonport, Launceston and New Norfolk.

#### Professional services engaged

The Board has engaged a number of professional services to assist the Board in meeting its obligations to the Tasmanian community. These are listed below.

#### AUDIT OF GRANT RECIPIENTS

To assist the Board in ensuring public funds are expended properly by grant recipients, from 2007 we engaged accounting firm Deloitte Touche Tohmatsu to audit medium and large grants.

This has ensured consistent auditing of those grants; assisted grant recipients to understand their obligations to account for the expenditure of public funds; and provided some certainty over timing of the audits.

In 2009, consistent with revised Treasurer's Instructions, the Board approved an increase to \$50 000 for the minimum grant size requiring an audit. However, the Board may also nominate smaller grants for auditing purposes.

#### WEBSITE AND COMMUNICATION MATERIAL

Following an expression of interest process the Tasmanian Community Fund Board appointed Futago to develop a new website for the Fund. The new website was launched in late 2011.

Futago was also engaged to produce a variety of communication materials to help promote the Fund to the Tasmanian community.

#### STRATEGIC PLANNING

In late 2011 the Tasmanian Community Fund sought expressions of interest from suitable individuals and organisations to work with the Board to develop a strategic plan. SCA Marketing was appointed and worked with the Board, over two days, to develop a five year strategic plan for the Tasmanian Community Fund.

The Board has retained SCA Marketing to support the Board with occasional reviews of progress towards the goals agreed in the strategic plan.

#### **BOARD PERFORMANCE AUDIT**

Following an expression of interest process the Tasmanian Community Fund Board appointed KPMG to undertake a Board Performance Audit. The audit provided the Board with an assessment of its overall performance and suggested areas for improvement.

#### **GRANT MANAGEMENT SYSTEM**

To streamline administrative processes and to allow for better management of the increasing number of applications, the Tasmanian Community Fund Board sought information on alternative grant management systems. The Board has agreed to invest in SmartyGrants with the system to be fully implemented in 2013.

#### MEDIA

For the first six months of the year the TCF retained the services of CPR to provide specialist media advice and coordination.

At the beginning of 2012 the Tasmanian Community Fund Board called for expressions of interest from suitable businesses to continue to provide this service. At the conclusion of this process the TCF retained the services of Corporate Communications. Corporate Communications assisted the Board in preparing media stories for mainstream and local media, preparing press releases, preparing a media management plan and other media advice.

Throughout the year, many grant recipients received coverage on television news, in the regional and local newspapers, on radio and the internet. This helps promote the Fund to other community organisations, and provides a level of accountability to the community on how the funds are being used.

#### Conferences attended

Board member Sheryl Thomas and staff member Lola Cowle attended *Our Community's Best Practice in Grant Making* conference in Melbourne in February.

Participants heard about:

- trends in grant making;
- risk management;
- · continuous review and improvement; and
- grant management systems.

The conference provided Fund representatives with an opportunity to meet with other mainland grant bodies providing grants in Tasmania.

To be eligible to apply, organisations must be:

- not for profit;
- incorporated or be a not-for-profit legal entity, or sponsored by an incorporated organisation or a not-forprofit legal entity; and
- based in Tasmania, or proposing to undertake a project in Tasmania.

Our funding categories are:

- children and young people supporting children and young people to reach their potential
- community participation and recreation supporting participation and volunteering in community activities, pastimes and events
- community wellbeing and life skills supporting sustainable and healthy communities, improving individual and community resilience, and overcoming barriers
- connecting communities supporting connections between and within communities through technology, transport and infrastructure
- culture, arts and heritage supporting a creative Tasmania, and preserving and celebrating our history

**FUND FACTS** 2000–2012  The Board has awarded over \$2.73 million to Neighbourhood/
 Community Houses and the Tasmanian Association of Community Houses for infrastructure upgrades, equipment purchases and programs to help the Houses build inclusive communities across Tasmania. Preference in funding will be given to projects which best demonstrate:

- benefit to the Tasmanian community;
- innovation and proactivity;
- an integrated and collaborative approach, avoiding duplication;
- value for money;
- community support for the project, particularly from any partners;
- high levels of other financial or in-kind contributions;
- the ability to build and strengthen community capacity;
- · good prospects for successful implementation; and
- volunteer and community involvement with the project.

#### Funding exclusions:

- organisations with overdue reporting obligations for completed TCF projects;
- projects where funding is more suitably sourced from another organisation;
- projects which produce a private benefit to a specific business or person(s);
- projects that replicate services or programs that already exist within the community of interest;
- retrospective funding ie for costs already incurred before approval of funding is given;
- ongoing operational costs;
- conferences or festivals or anything associated with the running or attendance at such events;
- projects where the only outcome is an outing by bus or any other conveyance;
- loans; or
- where it is apparent that the applicant is becoming dependent on TCF funding.

Applicants should ensure they read and follow the guidelines published for each funding round.

# Note 1. Significant Accounting Policies

The Tasmanian Community Fund (the Fund) was established under section 33 of the *Trust Bank Sale Act 1999* (repealed) and is continued under section 4 of the *Tasmanian Community Fund Act 2005* (the Act). These Financial Statements cover the period from 1 July 2011 to 30 June 2012.

# 1.1 BASIS OF ACCOUNTING

Under the provisions of the Act, the Tasmanian Community Fund Board (the Board) is required to keep proper accounts and records of its transactions and affairs. The Financial Statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board.

Compliance with the Australian Accounting Standards may not result in compliance with International Financial Reporting Standards, as the AAS include requirements and options available to not-for-profit organisations that are inconsistent with IFRS. The Fund is considered to be notfor-profit and has adopted some accounting policies under the AAS that do not comply with IFRS.

The Financial Statements have been prepared on an accrual basis and, except where stated, are in accordance with the historical cost convention. The accounting policies are generally consistent with the previous year.

The Financial Statements have been prepared as a going concern. The continued existence of the Fund in its present form, undertaking its current activities, is dependent on Government policy and on continuing appropriations by Parliament for the Fund's administration and activities. The Financial Statements were signed by the Chairperson on 13 August 2012.

# 1.2 SIGNIFICANT ACCOUNTING POLICIES

It has been determined that the Fund is not a reporting entity, and accordingly, this financial report is a special purpose financial report. Where practical the reports are prepared in accordance with current Australian Accounting Standards. Specific standards that were complied with include:

AASB 101 – Presentation of Financial Statements AASB 107 – Statement of Cash Flows AASB 108 – Accounting Policies, Changes in Accounting Estimates and Errors AASB 110 – Events after the Reporting Period AASB 119 – Employee Benefits AASB 1031 – Materiality AASB 1048 – Interpretation of Standards.

### 1.3 PURPOSE

The Fund is used to fund the payment of grants for community purposes. These include grants for community welfare, sporting or recreational, cultural and arts, educational, religious purposes, youth issues, health, environment, regional development and economic development and employment.

# 1.4 FUNCTION AND PRESENTATION CURRENCY

These Financial Statements are presented in Australian dollars, which is the Fund's functional currency.

# 1.5 INCOME FROM TRANSACTIONS

Income is recognised in the Statement of Comprehensive Income when an increase in future economic benefits related to an increase in an asset or a decrease of a liability has arisen that can be measured reliably.

#### a. Interest

Interest is brought to account, where possible, on an accrual basis, otherwise as it is received.

# 1.6 EXPENSES FROM TRANSACTIONS

Expenses are recognised in the Statement of Comprehensive Income when a decrease in future economic benefits related to a decrease in an asset or an increase of a liability has arisen that can be measured reliably.

# a. Administration services

The Board may make arrangements with the Secretary of the Department of Premier and Cabinet for persons employed in the Department to be made available to the Board to enable it to perform its functions. The cost of administrative services includes salaries and wages, payroll tax, superannuation and travel costs of staff available to the Board from the Department.

# b. Board Fees

A member of the Board is to be paid such remuneration, expenses and allowances as the Governor may determine.

### c. Other Board Costs

These are costs associated with employer superannuation contributions, payroll tax and travelling expenses attributable to Board members.

# 1.7 OTHER ECONOMIC FLOWS INCLUDED IN NET RESULTS

Other economic flows measure the change in volume or value of assets or liabilities that do not result from transactions.

# a. Impairment - Financial assets

Financial assets are assessed at each reporting date to determine whether there is any objective evidence that there are any financial assets that are impaired. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

All impairment losses are recognised in the Statement of Comprehensive Income.

b. Impairment – Non-financial assets The Fund's non-financial assets are not subject to impairment.

# 1.8 ASSETS

Assets are recognised in the Statement of Financial Position when it is probable that the future economic benefits will flow to the Fund and the asset has a cost or value that can be measured reliably.

# a. Cash and deposits

Cash means notes, coins, any deposits held at call with a bank or financial institution, as well as funds held in the Special Deposit and Trust Fund. Deposits are recognised at their nominal amounts.

#### b. Receivables

Receivables are recognised at amortised cost, less any impairment losses. Due to the short settlement period, receivables are not discounted back to their present value.

#### c. Tax assets

A tax asset is the input tax credits receivable from the Australian Tax Office and is recognised at the amount receivable.

# d. Prepayments

Prepayments are recognised when they occur and are measured at the nominal amount.

# 1.9 LIABILITIES

Liabilities are recognised in the Statement of Financial Position when it is probable that an outflow of resources embodying economic benefits will result from the settlement of a present obligation and the amount at which the settlement will take place can be measured reliably.

# a. Payables

Payables, including goods received and services incurred but not yet invoiced, are recognised at amortised cost which, due to the short settlement period, equates to face value, when the Fund becomes obliged to make future payments as a result of a purchase of assets or services or the finalisation of a Grant Agreement and all conditions precedent thereto having been met.

# b. Employee Benefits

Liabilities for wages and salaries and annual leave are recognised when an employee becomes entitled to receive a benefit. Those liabilities expected to be realised within 12 months are measured as the amount expected to be paid. Other employee entitlements are measured as the present value of the benefit at 30 June 2012, where the impact of discounting is material, and at the amount expected to be paid if discounting is not material.

A liability for long service leave is recognised, and is measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date.

#### c. Superannuation

The Fund does not recognise a superannuation liability for the accruing superannuation benefits of employees. This liability is held centrally and is recognised within the Finance-General Division of the Department of Treasury and Finance.

# d. Tax liability

A tax liability is the Goods and Services Tax payable to the Australian Taxation Office and is recognised at the amount payable.

# **1.10 TAXATION**

The Fund is exempt from all forms of taxation except Fringe Benefits Tax, Payroll Tax and the Goods and Services Tax.

Revenue, expenses and assets are recognised net of the amount of GST, except where the GST incurred is not recoverable from the Australian Tax Office.

In the Statement of Cash Flows, the GST component of cash flows arising from operating, investing or financing activities which is recoverable from, or payable to, the Australian Taxation Office is, in accordance with the Australian Accounting Standards, classified as operating cash flows.

# **1.11 JUDGEMENT AND ASSUMPTIONS**

In the application of Australian Accounting Standards, the Fund is required to make judgements, estimates and assumptions about carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised if the revisions affect only that period, or in the period of the revisions and future periods if the revisions affect both current and future periods.

There are no significant judgements made by the Fund.

The Fund has made no assumptions concerning the future that may cause a material adjustment to the carrying amounts of assets and liabilities within the next reporting period.

# 1.12 COMPARATIVE FIGURES

Comparative figures are adjusted to reflect any changes in accounting policy or the adoption of new standards. There has not been any change in accounting policy or new standards impacting on the Fund during 2011–12.

# 1.13 ROUNDING

All amounts in the Financial Statements have been rounded to the nearest whole dollar, unless otherwise stated.

# Note 2. Events occurring after Balance Date

No events have occurred after the reporting date for which a financial effect has not been recognised.

# Note 3. Income from transactions

# 3.1 SECTION 5 RECEIPTS

In accordance with section 5 of the Act, the Fund receives an annual appropriation through the State Budget. This funding is provided from the Consolidated Fund and is a Reserved by Law appropriation, in accordance with the provisions of the Act.
